

# Secure Medicine Return



## Reducing access to prescription drugs to protect our children & our families

### **Prescription drug abuse is a serious and growing problem in our communities.**

Abuse of medicines—especially opiate pain relievers like OxyContin, codeine, and Vicodin—is increasing rapidly.

**The consequences are serious.** Drug overdoses have surpassed car accidents as the leading cause of accidental deaths in Washington. The majority of overdoses involve prescription opiates. Youth admissions to state funded treatment for prescription opiates are now 19 times higher than in 2001.

**Our kids and teens are at risk.** Misused prescription drugs are the illicit drugs of choice among 12- and 13-year olds. For the first time among teens, there are as many new abusers of prescription drugs as marijuana abusers.

**Our medicine cabinets are taking the place of drug dealers.** Three in five teens say prescription pain relievers are easy to get from parents' medicine cabinets. Over half of prescription drug abusers get the medicines from a friend or relative. More than half of teens say pain relievers are "available everywhere".

## Medicine Return Programs can help reduce access to prescription drugs to prevent abuse.

**Getting rid of unneeded medicines from our homes safely helps reduce access to drugs that could be abused.** Flushing medicines is bad for the environment, and measurable amounts of drugs end up in downstream drinking water. Throwing medicines in the garbage—especially drugs like OxyContin—is just not safe because the drugs can be obtained and used illegally.

**Medicine return programs provide a secure way to dispose of pain relievers and other unwanted medicines.** By partnering with law enforcement, medicine return programs can securely collect and destroy controlled substances. Sheriffs and police are operating drug take-back programs in Clallam, Clark, Snohomish and Thurston Counties, as well as the Cities of Fife, Issaquah, Longview, and Sammamish. Mercer Island, Puyallup, and Pierce County are considering programs.

**We need a sustainable source of funding to ensure that everyone in our state has access to a medicine return program.** Voluntary programs at some police stations and some pharmacies demonstrate the strong community demand for drug take-back, but these are stop-gap measures without long-term funding, and serve only a small percentage of the state.

**The Secure Medicine Return Bill (2SHB 1165 / 2SSB 5279) will ensure that a secure and convenient statewide medicine return program is provided by medicine producers.** These companies already provide and pay for medicine return in British Columbia and several European countries.
